3 PRICE LIST MARKET DATA

The following prices apply for market data products on NOTC:

Market data products offered by NOTC:

- **End of Day share prices.** Share price information is not transmitted to the Client. The Client is allowed to download the price information directly from the NOTC web site. Monthly fee is NOK 1,000.
- **Share price information.** Share price information is transmitted to the Client as a snapshot picture ever 2nd minute during the system's opening hours. Monthly fee is NOK 2,500. In addition, a current operating fee in the amount of NOK 2,800 per month is to be paid for the FTP service.

1.1	<p>The admission fee will be invoiced after registration of a company's securities on NOTC. In the event NOTC AS has made a decision of registration and the company withdraws the registration, an administration fee of NOK 5,000 will incur.</p> <p>The admission fee is reduced for companies that is registered on NOTC 90 days or less due to a listing on a market operated by Oslo Børs. For companies registered 30 days or less, the admission fee is reduced by 50%. For companies registered 90 days or less, the admission fee is reduced by 25%.</p> <p>The registration fee will be invoiced the following half-year after the Company has been registered and will be invoiced in advance every six months on 1 January and 1 July respectively.</p>
1.2	The registration fee will be invoiced the following half-year after the Company has been registered and will be invoiced in advance every six months on 1 January and 1 July respectively.
2	The monthly fee for member will be invoiced in advance every three months.
3	<p>The fees for market data products will be invoiced in advance every three months.</p> <p>The Client is obligated to report any changes in tier status as soon as possible to NOTC@euronext.com.</p> <p>A fee of NOK 2,500 (non-recurring cost) is charged for historical data.</p>
